#### **Terms and Conditions**

The Account Owner and/or Property Owner as well as the Qualified Contractor agree to the following Terms and Conditions and hereby certify that all information provided on the application is accurate, complete and that any existing equipment replaced was disposed of properly.

#### **Rebate Availability**

The Columbia Gas of Pennsylvania Residential Prescriptive Rebates Program ("Program") for Energy Efficiency Rebates has been approved by Pennsylvania's Public Utility Commission and may be subject to changes at any time. Applications must meet all of the following criteria in order to qualify for a rebate:

- Rebates are only available to existing residential customers of Columbia Gas of Pennsylvania. This application must be signed by the Columbia Gas
  of Pennsylvania Account Owner and/or Property Owner as well as the Qualified Contractor. Account Owner must be a Columbia Gas of Pennsylvania
  customer at the time of new measure purchase.
- Available rebates are for new measures (not refurbished or used) in the original packaging, must be replacements of existing measures and must be purchased and installed at the Account Owner's service address by a Qualified Contractor doing business in the applicable field (e.g., insulation installer, plumber, HVAC technician, or electrician) with the exception of a smart thermostat which can be installed by Owner. Insulation Rebates must include both insulation and air sealing measures in order to qualify for a rebate. New construction and additions to a home's square footage do not qualify for rebates.

The rebate application must be received within 120 days of purchase and installation or by December 31, 2025, whichever is sooner.

- Account Owner and/or Property Owner as well as the Qualified Contractor is/are responsible for obtaining all required permits related to the
  installation of the new measures.
- · Account Owner may receive a rebate for up to two smart thermostats within a 3-year period at the same service address.
- Primary heat source for installed measures must be natural gas
- Rebate quantities are limited and are approved on a first come first served basis. Rebates are not guaranteed. Program funding is limited to levels approved by Pennsylvania's Public Utility Commission.

Note, rebate applications that are not submitted in a timely manner, are missing information, do not include all required documentation, or are approved after applicable funding runs out, will be denied rebates. Please check www.ColumbiaGasPA.com/WarmWise for Program updates. Program rebates are subject to Columbia Gas of Pennsylvania verification of application information which may include Program compliance site visit by Columbia Gas of Pennsylvania or its representatives.

#### **Rebate Qualifications**

Efficiency measures must be installed in the residential service address within Columbia Gas of Pennsylvania's service area. Applicants who receive a rebate greater than authorized, whether through fraudulent application or through a processing mistake, agree to refund the money back to Columbia Gas of Pennsylvania. Qualified Contractor must recycle or otherwise properly dispose of old equipment.

#### **Applications Details**

Columbia Gas of Pennsylvania issues rebates in the form of checks, not utility bill credits. Columbia Gas of Pennsylvania is not responsible if your retailer or Qualified Contractor provides inaccurate information about the amount and/or conditions of the actual rebate, and Columbia Gas of Pennsylvania will not pay rebates for efficiency measures that are mislabeled or misrepresented by dealers or Qualified Contractors regarding rebate qualifications. Applications are subject to verification by Columbia Gas of Pennsylvania. If your application is selected for verification, it will not be processed until the verification process is satisfactorily completed.
